

International Commission of the Anglican-Orthodox Theological Dialogue

September 2010 Communiqué
Oxford, England, United Kingdom



Under the blessing and guidance of God, the All Holy and Blessed Trinity, the International Commission for Anglican-Orthodox Theological Dialogue met in Oxford, from Tuesday 31 August to Tuesday 7 September 2010, at Christ Church. The Commission was grateful for the hospitality offered by the Anglican Communion.

The participants were welcomed to Oxford by Archbishop Gregorios of Thyateira and Great Britain, the Very Revd Christopher Lewis, Dean of Christ Church, and Dr Colin Thompson, the Senior Proctor of the University of Oxford.

The Dialogue consists of official representatives of the Orthodox Church and of the Anglican Communion. It began its work in Oxford in 1973. Previous sessions of the Commission have resulted in the *Moscow Agreed Statement* of 1976, and the *Dublin Agreed Statement* of 1984, and in the *Cyprus Agreed Statement* of 2006, entitled *The Church of the Triune God*.

The Commission in its current phase begun in 2008 is focussing on Christian anthropology, seeking to build on the insights from the *Cyprus Agreed Statement*. Papers were given to clarify Anglican and Orthodox approaches to the question. Particular topics covered were the human being as the image and likeness of God, meanings of human freedom, the human being in the understanding of patristic anthropology and modern Orthodox theology, Anglican theological methodology, and the broader implications of the theology of the human person in politics and society, and in pastoral responsibility for God's creation.

Members welcomed Dr Rowan Williams, the Archbishop of Canterbury, who spoke on Richard Hooker's theological anthropology and its influence on Anglican theology. Members also were grateful both for his presence at Orthodox Vespers, and as president and preacher at the Eucharist in the Anglican Cathedral. He also engaged in further discussions on current developments in the Anglican Communion, and affirmed the importance of the continuing work of the Dialogue. All members greatly appreciated the opportunity to listen and converse with the Archbishop.

The work of the Dialogue was undergirded by daily prayer, including a memorial service for Professor Constantine Scouteris, a former member of the Commission. Members attended services at the Orthodox Church of the Holy Trinity and the Annunciation, and at Christ Church Cathedral. On the occasion of its 50th anniversary, the House of Saint Gregory and Saint Macrina hosted members of the Commission at an evening reception.

Members enjoyed visiting important institutions in Oxford, including the Bodleian Library, the Ashmolean Museum, and several historic colleges.

Throughout its sessions the Commission affirmed the dignity and potential of the human person in God's love, which offers hope in the face of a prevailing narrow and pessimistic secularism.

At the invitation of Archbishop Anastasios of Tirana and All Albania, the Commission will next meet in Albania, from 16 to 23 September 2011.
